

Objective HHM1: Stabilize and restore 15,000 LF of stream channel using bioengineering techniques and natural stream channel design techniques.

Objective HHM2: Reconnect 7,000 linear feet floodplain in incised channels.

Objective HHM3: Daylight 4,000 ft of buried stream

Objective DRZ2: Reforest 360 acres of riparian buffer

Objective FPB1: Remove or modify 6 dams or inline basin outlet structures to allow for fish migration.

Objective FPB2: Remove or modify undersized culverts to allow for fish migration.

Objective DCI1: Reduce the rate/amount of stormwater runoff by mitigating impervious area in the riparian buffer zone to reach <10%

Objective LIA1: Reduce the rate and amount of stormwater runoff by mitigating impervious area to reach <18%

Objective LIA2: Add green infrastructure to existing and new development sites, retrofit existing SCMs, remove impervious surfaces and replace with pervious)

Objective PRES1: Protect 2,056 acres of undeveloped parcels, greenspace, forest, wetland, floodplain, riparian, and headwater habitat in the Euclid Creek watershed through ordinance modification, easements, acquisition, and other means.

Objective PRES2: All Euclid Creek Watershed Communities will adopt and enforce riparian, wetland, and steep slope setback ordinance.

Objective HSTS1: Upgrade 15 off lot discharging HSTS to newer permitted design.

Objective HSTS2: Connect 40 residences utilizing off lot discharging HSTS to municipal sewer system.

Lake Erie Stormwater Rebate Program Pilot Year

Goal: Promote stormwater management on residential properties by removing barriers and educating landowners.

- Offering rebates on rain barrels and rain gardens to South Euclid residents
- Program developed by CLEB through a community and public engagement process funded by the Northeast Ohio Regional Sewer District (NEORSD).












